Philosophy

We believe that the early years of a child's life are precious.

Our motto 'Learning, Caring, Sharing' provides the framework within which we carry out our aims for all of our children.

LEARNING

We nurture all of our children in order for them to:

- develop a lifelong love of learning through first hand experiences both in the classroom and beyond
- have the courage to try new things and be brave enough to sometimes get things wrong
- evoke curiosity and an eagerness to learn

CARING

We help our children to:

- care for themselves, for other people and for the world in which they live
- recognise and value each and every individual
- feel safe and secure and to have a sense of belonging

SHARING

We encourage our children to:

- learn independently, with others and within their wider community
- share everyone's achievements, however large or small
- be proud of themselves and each other

Aims

The school recognises its duty under the DDA (as amended by the SENDA):

- not to discriminate against disabled pupils in their admissions and exclusions, and provision of education and associated services
- not to treat disabled pupils less favourably
- to take reasonable steps to avoid putting disabled pupils at a substantial disadvantage
- to publish an Accessibility Plan

The school provides all pupils with a broad and balanced curriculum, differentiated and adjusted to meet the needs of individual pupils and their preferred learning styles; and endorses the key principles in the National Curriculum 2014, which underpin the development of an inclusive curriculum:

- setting suitable learning challenges
- responding to pupils' diverse learning needs
- overcoming potential barriers to learning and assessment for individuals and groups of pupils

The school will continue to take the advice of specialists, including health professionals, LA advisors and architects to enable the school to take account of the needs of pupils and visitors with physical difficulties and sensory impairments.
